PRESIDENT'S MESSAGE

Your provincial executive is working to build bridges with the Pension Board, O.T.F. and the Affiliates, and to establish contact with the Ontario Principals' Council. We need to support these initiatives by encouraging our own new and present retirees to join our RTO/ERO organization of over 42,500 members. The more members – the greater influence on governing bodies, the more activities we can explore, and the more valuable and dynamic District 16 can become.

RTO/ERO is now monitoring and lobbying Districts that are negotiating changes to <u>Board</u> Benefit Plans. If you are under 65 and still a Board Benefit Plan member, you may be affected in the next round of negotiations with Metro Teachers. Several Board Benefit Plans in the province, with its new Boards, have seen reductions in benefits for retirees.

The provincial Senate has commissioned an examination of possible changes in the organization of our Districts and has established a committee to look into this. This committee, of which I am chair, is seeking to maintain local autonomy while initiating connections with the new boards. Presently 25% of your fee is returned to District 16 so that our priorities as to how we serve our members belongs to your own local executive.

Watch for the new Affinity Program in the next provincial newsletter. RTO/ERO is seeking commitments from companies to gain reductions, bonuses and special consideration for our members. More information will come out after the May Senate.

Club Sixteen is active. If you have any ideas you'd like to explore – forming a band, building a canoe, setting up walking tours, etc. – maybe we can help you get a group together. Are you an Artist? 1999 Income Tax Reminder

Members of the RTO/ERO Health Plans are reminded that the Health Insurance premiums, including PST, are tax deductible on their 1999 Income Tax Forms.

Your total expenses have to be more than either \$1,614 or 3% of your net income, whichever is less.

In the case of couple coverage, the person with the lower income should make the medical claim.

Remember also that any parts of claims unpaid by Johnson Inc. or other medical expenses not covered by the Plans can be claimed.

Receipts are required for all expenses except for the health plan premiums.

A note should be attached to your tax return stating that the plan is underwritten by Maritime Life and give the plan name and number for the applicable coverage.

To facilitate your claim (for Ontario Plan members), I have included below the exact amounts you should claim under each plan for 1999. I have included the PST.

	<u>Single</u>	<u>Couple</u>	<u>Family</u>
Semi-Private Hospital Plan (No. 983429)	\$249.00	\$497.52	\$584.52
Dental Plan (No. 983431)	\$423.96	\$835.92	\$1,042.32
Extended Health Care Plan (No. 983430)	\$425.16	\$850.44	\$1,020.60

If you have not been a plan member for a full year, just divide the given amount by 12 and multiply the answer by the number of months you have paid.

<u>Supplemental Out-of-Province</u> premiums (No. 6983432) can also be claimed and 8% PST (for Ontario residents) should be added to these premiums.

Further information re Medical Expenses can be found on pages 32 and 33 of the <u>1999 General Income Tax</u> and Benefit Guide (available at most Canada Post outlets).

MINDING YOUR MONEY - by Chuck Carr

RRIF Transfers

Beginning in 1999, individuals may now designate *qualified dependents* (i.e., financially dependent) as recipients of the unused portion of their RRIFs when they die. These amounts may roll over tax free into the dependents' RRSPs/RRIFs. These RRIF roll

overs are possible even if there is a surviving spouse.

Retroactive Lump Sum Pension Payments

Qualifying retroactive lump sum payments (i.e., income tax on past income) will be allowed a special *averaging mechanism*, if the amounts exceed \$3,000. Eligible income sources include superannuation or pension benefits, or other non-periodic benefits.

If you qualify for this provision, the Ontario Pension Board will have issued a Form T1198, Statement of Qualifying Retroactive Lump Sum Payment. Attach this form (keep a photocopy) to your tax return and report the full amount received (i.e., include interest). Revenue Canada (now called the Canada Customs and Revenue Agency – CCRA) will determine whether utilizing this provision is to your advantage, and adjust the interest of affected returns accordingly.

Income Tax Form Changes

CCRA has changed the Income Tax Return quite significantly for 1999. Amounts, hitherto found on their own schedules, now form part of a new *Worksheet*.

Caregiver Amount (Line 315)

This non-refundable tax credit remains the same for 1999, but is now included on CCRA's new *Worksheet*, instead of on Schedule 12.

Disability Amount (Line 318)

If your spouse or other relative has a severe or prolonged disability that significantly diminishes her/his functioning, be certain to apply for a disability credit. Obtain a Form T2201 from CCRA and have your family doctor (or optometrist for vision, audiologist for hearing, occupational therapist for movement, psychologist for emotional) complete it. The non-refundable deduction is currently \$4,233 per year.

Tax Tip

If you or anyone else paid for an attendant or for care in a nursing home or any other establishment because of the impairment, it may be more beneficial to claim the amounts paid as Medical Expenses instead of the Disability Amount. In some circumstances, both amounts may be claimed. See CCRA's 1999 General Income Tax and Benefits Guide.
