### **Ontario Teachers' Pension Plan Issues**

- 1) The Federal Government announced in March its intent to impose a 1% cap on investments by pension plans in business trusts. This will negatively affect the OTPP. RTO/ ERO will be working with the OTPP to make this a political and a financial issue. Your help may be needed. Stav tuned!
- 2) From time-to-time, movements within and without the teachers' unions launch programs designed to put public pressure on the OTPP to invest 'more ethically'. Although their goals may be laudable, they are usually based on limited knowledge and small issues are extrapolated to make the OTPP investment appear inappropriate. Before retirees decide to participate in such programs, they should consider that their own pensions are guaranteed. It would be disingenuous for one with a guaranteed pension to advocate an additional level of investment restriction that could cost current working participants increased premiums. Note that current investment processes of the OTPP give due consideration to ethical issues while fulfilling the legal investment restrictions placed on pension plans by federal/provincial governments. # President's Message - continued from Page 1

### **Provincial RTO/ERO**

By the time you read this, Spring Senate will have determined the outcome of the following issues. An update on these matters will be available on our website and in our September Newsletter.

- 1) At Fall Senate, 2003, your district introduced a motion that would reimburse the RTO/ERO membership fee for those 100 years and older. Spring Senate, 2004 will consider a motion to waive the RTO/ERO group health plan premiums for these same individuals.
- 2) In a previous newsletter we referenced a move by the provincial organization to begin a program of **support for Works in Developing Countries**. Your Toronto executive has taken a position in opposition to this move and we asked for your view on the matter. All communications received agreed with your executive. This opposition was communicated to the provincial executive but to no avail. A motion will be introduced to Senate to establish a fund of \$50 000 for this concept. Your representatives to Senate will oppose this new program. Unfortunately, we believe that we are the only district to have brought this matter to its members for reaction. It is expected to be a struggle to counter the violins in order to defeat the proposal.
- 3) On a matter that may be related, there is some legitimate concern about the **growing surpluses** accruing to many local districts. Some members are arguing that fees collected from members should be used for those members. That, aside from some maintaining surplus funds for unexpected situations, there should be no massive build-up of large bank accounts in the name fiscal efficiency. However, provincial RTO/ERO finds itself with growing surpluses too. Hence, a search for more opportunities to spend. The Works in Developing Countries Program, the new Special Circumstances Grant, the expanded Service to Others Grant have become ways to spend the growing surplus funds and one expects to see even more creative ways to spend your fees. It is the position of this writer that if there are growing surpluses

both locally and with the provincial RTO/ERO, there ought to be a reduction in membership fee. Even a token \$0.05 reduction would better show efficient use of member fees than looking for additional expenditures. Please let us know your point of view on these matters so they can be represented accurately. If there is a general membership feeling to keep fees at the current level then, perhaps, the establishment of a new service for members might be appropriate ~ like a legal referral service; or, an RTO/ERO troubleshooter for members who are having difficulties with government agencies, nursing homes, frauds/scams, billing issues with private companies, etc.

### **Federal Election**

Again, by the time you read this, a federal election may have been called. We encourage our members to VOTE. Complete the **survey** included in this Newsletter ~ the data collected will help the Political Action Committee influence the candidates.

When you vote, consider what is not said by the various parties. Remember what happened to health, education, and government services in Ontario in 1997 when the party that took power made drastic changes to these programs after having made no reference to them in the election campaign itself.

# REVIEW OF THE ONTARIO TEACHERS' FEDERATION (OTF)

After the OTF facilitated review with the Honourable George Adams (a process begun with the legal sparring between OTF and OSSTF), a proposal to change the Membership By-laws is being made to the Board of Governors as follows:

- to accommodate the possibility of a non-teacher being elected or appointed to an Affiliate office that has a seat on the OTF Board of Governors or the OTF Executive by virtue of the Teaching Profession Act;
- to exclude from decision-making on pension issues those members of the Board or Executive who are not members of the Ontario Teachers' Pension Plan;
- to provide for substitution at the Board of Governors or re-assignment of the vote of such persons at the OTF Executive;
- to provide for the Affiliates to choose whether to join the Canadian Teachers' Federation (CTF) directly, effective in 2005-2006 while maintaining a vote for OTF at CTF.

The Executive also agreed, as a result of the review, to undertake a process to clarify the three pillars around which OTF's work is currently organized: advocacy, legislation and pensions. The Executive will engage in regular planning and review of OTF under the three pillars.

# HEALTH SERVICES & INSURANCE COMMITTEE UPDATE

(District 16 Editor comments in italics)

The RTO/ERO Health Services & Insurance Committee has approved a number of actions regarding Benefits:

- Received financial results of RTO/ERO Health Plans for 2003, indicating **a year-end surplus of approximately \$3.6 million**. These are used to stabilize premium rates over time and/or permit plan improvements sans premium increases.
- Increased the **benefit for special contact lenses from \$200 to \$250**, retroactive to January 1, 2004; this parallels the 2004 increase in the Vision Care benefit (from \$175 to \$225), and maintains the historical difference between the two related benefits, at minimal cost.
- Eliminated the Supplemental Travel Plan Re-Entry fee (\$50), retroactive to September 1, 2003.
- Received the new **Long Term Care Plan (design and pricing)**, and authorized Johnson Inc. to send a letter to existing LTC policyholders in April outlining their options and related costs, accompanied by an explanatory letter from the Chair of the HSI Committee. The voluntary Long Term Care Plan was implemented as a new program available through RTO/ERO. Since this type of insurance was relatively new when first offered, rates were guaranteed for 5 years but understood that, without a claims history, rates at the end of the 5 years might change significantly.

• Moved that necessary measures be taken to discontinue RTO/ERO's current Affinity Programs, effective immediately. For retirees, there are no benefits available better than one can obtain because of age or other common affinity programs offered via credit card, CAA, others. ADDITIONALLY - there are tax implications for RTO/ERO Members' Fees should the organization provide these types of benefits.

# TORONTO HOTEL CORPORATE RATE FOR RTO/ERO MEMBERS

RTO/ERO members may take advantage of our hotel corporate rate for 2004 when visiting Toronto, by staying at the Courtyard by Marriott Hotel located at 475 Yonge Street (College & Yonge). The seasonal discount rates are:

A *Fraud Free Calendar* with information on protecting oneself against scams and frauds **is available free of charge** at the Ministry of Consumer and Business Services website, www.cbs.gov.on.ca. Or phone 416.326.8800.

A *Guide to Advance Care Planning* has been developed by the Provincial Government, as part of Ontario's Strategy for Alzheimer Disease and Related Dementias. It is designed to help people know and exercise their rights in preparing for a time when they may be unable to make decisions about their care. This 44-page booklet contains much useful information on making choices now about future personal care needs. ### **PROTECTION** for Senior Citizens

Criminals often regard older persons as easy **targets** for many kinds of crimes. Every elderly person should be aware of these crimes and how to prevent them.

### **CON-GAMES AND SWEET-TALK CRIMES**

**PIGEON DROP:** This scheme accounts for more than half of the confidence games reported to the police. The swindlers claim to have found a large sum of money and offer to share it with you. You are asked to withdraw "good **faith**" money from your bank. The swindlers take the "good **faith** money" and give you a phoney address where you are to collect your share of the found money. You never see them again.

**BANK EXAMINER:** A phoney bank examiner contacts you and asks for your help in catching a dishonest bank mployee. You are asked to withdraw a specified amount of cash from your account so that the examiner may check the serial numbers. After turning over your money, you never hear from the examiner again.

**DOOR -TO -DOOR SALES:** Many door-to-door sales are not legitimate. Provincial laws protect you against quick sales at your door. Enquire and be sure.

### MAIL FRAUD SCHEMES

**CONSUMER FRAUDS:** Beware of contests which require you to put up money to win, even if there is a guarantee that you will be a winner.

**HOME IMPROVEMENT OFFERS:** Beware of tempting home improvement offers, made through the mail or on-the-spot. These offers are a popular type of swindle.

**CHAIN-REFERRAL SCHEMES:** These schemes offer a commission for buying one item and selling additional ones to friends. The products are usually over-priced and difficult to sell.

**RETIREMENT ESTATES:** Any retirement estates offered at conspicuously low prices to "lucky" individuals are usually fraudulent and should be avoided.

**BUSINESS OPPORTUNITIES:** Business opportunities and work-athome schemes which promise high profits after a substantial investment or registration fee are often fraudulent.

**MEDICAL FRAUDS:** Fake laboratory tests, miracle cures, and mail order clinics, etc. are other ways schemed to defraud you. Legitimatedoctors and hospitals do not advertise through the mail.

### FOR YOUR PROTECTION

- Avoid rushing into something involving your money or property.
- Be wary of "something-for-nothing" or "get-rich-quick" schemes.
- Never sign a contract until you and your lawyer, banker, or other expert has thoroughly read it.
- Never turn over large sums of cash to anyone, especially a stranger, no matter how promising the deal looks.
- Do not hesitate to check the credentials of a salesperson or public official.
- Report all suspicious offers to the police immediately, before the swindler leaves town in search of other victims.
- Arrange for incoming cheques to be sent directly to your bank.
- Avoid burdening yourself with packages and a bulky purse.

### Other crime prevention tips...

### AT HOME

- Join **OPERATION IDENTIFICATION**.
- Install good locks and always use them.
- Don't leave tell-tale signs that you are away.
- Never open your door to a stranger without credentials. Install a wide-angle door viewer which permits you to see callers before you open the door.

## ON THE STREET

• Walk only in well-lit areas

- Never display large sums of money in public.
- Walk near the curb and away from alleys and doorways.

### **IN YOUR CAR**

- Always lock your car after entering and whenever leaving it.
- If you have car trouble, raise the hood, lock yourself in and wait for the police. If a stranger stops to offer help, do not get out of your car. Ask the stranger to call a service truck for you.
- If you suspect you are being followed by another vehicle, drive to the nearest police station, service station or restaurant and blow your horn.


