💓 Education Scholarships ~ An RTO/ERO Program 📺

At the Fall Senate, 2005 a system of Education Scholarships was established. This was reported to you in our Toronto District November Newsletter. The criteria are repeated below. About the time you get this March Newsletter, you should be receiving the RTO/ERO quarterly magazine '*Renaissance'* which will contain an application form and further details as to process. Note that within the criteria are some built-in equity factors. Note that a francophone member need not be a member of one of our French-langauge districts.

The Criteria for the Award of Scholarships be:

- 1. Each scholarship shall be in the amount of \$1,000
- 2. The applicant shall be a student full time or part time pursuing a career in education in Canada.
- 3. Each scholarship shall be for one time only.
- 4. Scholarships shall be organized and distributed on a provincial level.
- 5. Consideration shall be given to gender, geographical distribution and language balance based on the proportion of applications.
- 6. Scholarships shall be granted to children, grandchildren, nieces, nephews, grandnieces and grandnephews of RTO/ERO members.
- 7. The Project Service to Others Committee shall take on the role of the Selection Committee.

Minding Your Money ~ Chuck Carr Formal Trusts

When we think of *formal trusts*, we usually think of very rich people because formal trusts (not in-trust-for (ITF) accounts) are expensive to set up and maintain. Nevertheless, formal trusts can be a powerful tool in estate and income tax planning, and since so many people are winning lotteries or inheriting large bequests, it is helpful to have a rudimentary understanding of formal trusts.

It is essential from the outset to emphasize that a formal trust is merely a "container" that holds your assets. You still require the help of a certified financial planner (CFP) to advise you on the best way to invest the contents of the trust.

Reasons for setting up a formal trust might include: control and protection of minors or special needs children; protection of family members who are perceived to be lacking in financial acumen; income splitting to lower overall family taxes, protection from claims against family law or marital regime claims; confidentiality, minimizing estate probate costs; charitable giving; and/or specific retirement or estate planning goals.

Each province and territory has its own Trustee Act. Setting up a formal trust involves changing the *legal* ownership from the original owner, the *settlor*, to a new, legal owner, the *trustee*. The settlor decides who the trustee(s) will be, who the beneficiary(ies) will be, what will be held in trust, how the trust will operate, what powers the trustee (which may be the settlor) will have, and how long the trust will last. The terms of the trust may be set out in a person's last will and testimony or may be set out in a free-standing trust agreement.

There are many different kinds of trusts created for specific purposes. We will address just two trusts – *inter vivos* and *testamentary trusts*. An *inter vivos* trust is established *during the lifetime* of a settlor. A *testamentary* trust is established *upon the death of a settlor* - quite often under the terms of the will. Income that is not distributed to the beneficiaries and taxed at their personal tax rate will generally be taxed inside the trust at the appropriate tax rate. That way, beneficiaries of a trust may receive after-tax dollars and not lose much of an inheritance through taxes.

Types of Beneficiaries: The settlor may declare beneficiaries as income, capital or both. For example, in an income-splitting, testamentary trust, where

investment income is taxed inside the trust, the settlor might declare two types of beneficiaries. The settlor might declare his children as *income beneficiaries* who receive after-tax benefits from the trust (The trust pays the taxes on the investment income.) and the grandchildren as *capital beneficiaries*. In that way, the children enjoy the benefits of non-taxable income, and the grandchildren will ultimately receive the capital assets that generated that income.

Tax reporting from a trust is made using a Canada Revenue Agency (CRA) T3 Trust slip. Investors holding mutual fund trusts outside a registered shelter, (e.g. RRSP) receive T3 Trust tax slips each year.

The 21 year rule: In most tax jurisdictions in Canada, trust assets are "deemed" to be disposed of every 21 years. This is how CRA gets its taxes. All unrealized capital gains inside the trust will be taxed at this time. Tax planning is essential inside a trust because, after the 21 years, in order to pay the taxes on the *deemed disposition*, it might be necessary to sell some of the property at an inopportune time. That's why you need both income tax and financial advice to operate a trust.

If, after reading this article, you feel that a formal trust is for you, then visit a lawyer specializing in trusts or a trust company. I hesitate recommending a trust company because trust company employees are on commission and are expected to recommend that institutions proprietary products. In addition, these employees are seldom CFPs.






From the perspective of teachers in the classroom there are issues arising from the unsanctioned use of personal electronic devices (cell-phones, Blackberrys, MP3 Players, iPods, Camcorders and other Convergent Communications Devices):

- Bullying or harassment of students via unwanted text messaging;
- taking and distributing inappropriate digital photos of students or others;
- gang activities communications;
- calling students to fights;
- fighting for video downloading (We are seeing an increasing number of incidents of students goading others to fight and then these violent scenes are being video-recorded for posting on websites);
- Teacher baiting for downloading;
- sending friends text messages during class time, leading to general class distraction; and an overall shift, among some students, from an academic to a social focus.

As an aside, one wonders why there appears to be so much angst regarding surveillance cameras on Toronto streets when photo devices are common-place and their use is highly encouraged by the media as a substitute for their own news gathering. Ed.

Watch for Emergency Vehicles



There are two situations where motorists encounter an emergency vehicle on our roads and highways: when a police, fire or ambulance vehicle is approaching from either direction or when any of these vehicles, with their red lights flashing,

is stopped in the same direction on the road or the shoulder ahead.

Reacting to an approaching emergency vehicle

As required by law, a motorist who sees or hears an emergency vehicle must clear the way. When a police, fire or ambulance vehicle is approaching from either



direction, with lights flashing or siren on, motorists are required to pull to the right, and if possible, stop. This is especially important during peak traffic times. Also, motorists must yield to an emergency vehicle at intersections.

It is also illegal to follow within 150 metres a fire vehicle or ambulance responding to a call.

Failing to pull over and stop for an approaching emergency vehicle can result in the following:

Fine - \$90 (\$125 in a Community Safety Zone), plus 3 demerit points on your driving record upon conviction.

Approaching a stopped emergency vehicle



Enforcing the law and providing emergency assistance often require emergency vehicles to park in a lane or on the shoulder of a road or highway. To increase safety, Ontario's Highway Traffic

Act now requires motorists when approaching a police, fire or ambulance vehicle stopped with its red lights flashing in the same direction of travel, either in a lane or on the shoulder of a road or highway, to slow down and pass with caution. If the road has two or more lanes, the motorist must move over into another lane, if it can be done safely. Failing to do so can result in the following:

First offence - \$400 to \$2,000, plus 3 demerit points upon conviction. Subsequent offence (within 5 years) - \$1,000 to \$4,000, possible jail time up to 6 months and possible suspension of driver's licence for up to 2 years.

Claude Lamoureux on Ethical Investing

"Pension plans do not have the legal authority to restrict investments based on social, political or ethical criteria. This is the law. To quote the Senate Committee on Banking, Trade and Commerce: "The primary responsibility of pension funds should be to the beneficiaries of the fund. Social investment or any other form of investment must be subordinate to the long-term growth of the pension plan." We agree with that statement. Our job is to make sure there is enough money to pay your pensions far into the future. Because there are a lot of people counting on us for their pensions.

Finally, if all the teachers of Ontario want us to follow a social investment policy and are willing to take the risk of lower returns, then first agree on what is acceptable and what is not acceptable as an investment. Then convince the Ontario government — who is the other partner in the plan — to change the law."

RTO/ERO Survey Results continued from Page S9 Pensions, Insurance and RTO/ERO's Services

Observation: Health Plans are the most used RTO/ERO's service.

- Health Plans are retention drivers for both General and Executive members.
- Members report being satisfied with their current Health Plan, either RTO/ ERO or other.
- Older respondents tend to be less satisfied with RTO/ERO's services.
- Overall satisfaction with RTO/ERO is high.
- Satisfaction with the current Health Plan offered by RTO/ERO is high.
- Almost one-third of General respondents who have a Health Plan other than RTO/ERO have the Provincial Government's Health Plan.
- The main reason for satisfaction with current Health Plan is good coverage.
- Drug coverage is the most important factor with respect to Health Insurance.
- Younger respondents are more likely to consider Health Insurance features to be important.
- Members' Future Travel Plans Section Overview More than two-thirds of respondents are planning to travel fewer than 60 days per year in the next three to five years.
- Most members plan to travel fewer than 60 days per year in the next three to five years.
- Older respondents are more likely to not plan to travel in the next three to five years.
- The vast majority of respondents plan to travel outside of Ontario.

Future of RTO/ERO

Observation: Reaching out to new retirees is RTO/ERO's greatest strength.

- Almost half of General respondents would be willing to pay for extra services. (Your editors have some misgivings regarding the phrasiology of this particular item. Unless the writer of the report was trying to avoid negative words, we would have preferred a wording indicating that the majority of members prefer NOT TO PAY FOR EXTRA SERVICES - especially when matched with the fact that there is no consensus as to what those exrta services might be.)
- General members believe RTO/ERO should be an organization for Retired Teachers only.
- Executive members have a more positive attitude towards RTO/ERO than General members.
- Opinions about other services that RTO/ERO should offer are varied.
- Executive respondents are more likely to be willing to pay for extra services.
- More recent members are less willing to pay for extra services.

RTO/ERO Member Survey Results

In the Fall of 2006, RTO/ERO commissioned a Member Survey. Two variations of the Survey were distributed; one each to General Members and Executive Members. The Survey's full report is available at our website. We summarize the Survey results here along with some of our editorial comment. Ed.

Participation in RTO/ERO

Observation: General members are neither very likely to participate in District meetings nor volunteer for RTO/ERO.

- One-quarter of respondents have attended District meetings in the last two years.
- Respondents in Greater Toronto, East/Kingston and the North are more likely to attend District meetings.
- The main reasons for non-participation in RTO/ERO are lack of time and inability to commit.
- Executive members are more likely to volunteer in other organizations.
- More than two-thirds of respondents under 79 years old volunteer in other organizations.
- Respondents who volunteer for RTO/ERO tend to volunteer for other organizations as well.
- General members who live alone at home spend more hours volunteering.
- Three-quarters of General respondents are not willing to participate in volunteer activities for their local District of RTO/ERO.
- General members are not very interested in participating in RTO/ERO activities.

Community Services

• A small proportion of respondents use community services.

Renaissance

- Ninety-eight percent of respondents read Renaissance.
- Older members are more likely to read Renaissance cover-to-cover.

The Internet and RTO/ERO's Website

Observation: The numbers support further use of the Internet as a medium of communication by RTO/ERO. The majority of respondents have access to the Internet.

- One-third of respondents access the RTO/ERO website several times per year.
- Executive Members are more likely to agree that the information on the RTO/ ERO website is useful.
- As with Renaissance, most respondents are happy with the content on the website.
- The vast majority of Executive members find the information in the monthly District Updater useful.
