RTO/ERO Charitable Foundation ~ A Chair in Geriatrics

It has been a full year that we have encouraged our members to participate in this 3-year endevour to raise \$3,000,000. The full details of the goals of this effort can be found on both our provincial and local websites. Fully endorsed by your local executive, our approach to fund-raising has been to respect the fact that many support their personal charities. Therefore, our requests for participation have been quite low-key. We hope not so-much-so that thoughts of donation are out of mind.

We leave you with a couple of statistics about our Toronto District 16 and a brief summary of the Foundation's goal. **Donors**, donations and pledges, as of June, 2012: \$463,000 from over 680 donors!

- if only just-fewer-than-half of Toronto District 16's 4.500 members donated \$120/year for the 3-year effort, we would raise more than a quarter of the goal of 3 million dollars. $(2,200 \text{ members } \times \$120 \times 3 \text{ years} = \$792,000)$;
- If 4000 of our over 4,500 members donated \$250/year for the 3-year effort, Toronto District, alone, would raise the full amount of the 3 million dollars. $(4,000 \text{ members } \times \$250 \times 3 \text{ years} = \$3,000,000)$.

Editors: In 1989 Robert Lamb, an RTO/ERO Scarborough/East York member (right photo),

researched the history of RTO/ERO including the development of teacher pensions in Ontario. We use this source for the following summary. The origins of RTO/ERO coincides with pension benefits changes in the 1960s. More history in a future Newsletter.



The first pension fund for teachers in Ontario (Upper Canada) was **L** known as the **Ryerson Pension Fund** (1853) which provided a sum of 500 pounds sterling (~\$792.00/July, 2012) per annum for the support of "superannuated or worn out Common School Teachers of Upper Canada". This amount was later doubled and then tripled. While this amount was small Ryerson was very proud to state; "It is honourable to Upper Canada to be the first Province or State, in America to which any public provision whatever is made in aid of the support of Common School Teachers, when they shall have become worn out in the service of their Country." To be eligible for pension the teacher had to have contributed a pound per year to the fund and provide proof of inability to continue teaching due to age or loss of health. The allowance could not exceed \$6 annually for each year that the recipient had taught school in Ontario. In 1860 the average pension amounted to \$26.54.

In 1871 every male teacher in a public school was required to pay \$4.00 annually to the Fund with females also eligible on a voluntary basis. The fund was further enlarged by admitting high school teachers who wished to join. Allowances per annum were calculated at \$6.00 times the years of contribution and granted at or after reaching age 60 on presenting proof of age, good moral character and length of service. Teachers who held a First or Second Class provincial teaching certificate or who were principals of a high school were granted calculation based on \$7.00. Disabled teachers under 60 were eligible for pension under the same rules for calculation. Refunds were available to those who retired before pension eligibility to the extent of half the contribution. Spouses or legal representatives of teachers dying in service were entitled to refunds of contributions plus interest at 7%.

The 1871 plan incorporated the ideas of service time, age, disability, refunds and survivor benefits. It is not too long ago however that teaching candidates were required to have certificates of good moral character, and even today a teacher's duty includes being an exemplar of many stated virtues.

This plan was quite an advance at a time when a Minister of Education (in 1881) held that he "was against making pensions compulsory especially for Continued on Page 10 🖾 women and was also against giving a higher pension to those who remained for more than twenty-five years of service, for fear that teachers who had outlived their usefulness would continue teaching in order to get a larger pension."

In 1885 the Fund was closed to all except those who were members. No further grants were provided and the plan was phased out. No pension plan was available to new teachers until 1917 unless it were provided by an urban school board under 1904 legislation. These board plans lacked portability.

With the times not being favourable to better pension plans, teachers were largely the authors of their own misfortune in that they wanted better plans, but they were against plans that were compulsory. The Ontario Teachers Association as far back as 1871 voted unanimously against compulsory payments, calling them tyrannical, although it was obvious that benefits were tied to contributions and that these benefits could only be increased by a compulsory feature.

Following the closure of the Ryerson Fund to new entries in 1885, efforts were continued to achieve a better scheme. In 1901 the Ontario Educational Association resolved: "That in the opinion of this Association it would be in the interests of the teachers of Ontario to have established some scheme of superannuation under the control of the Education Department."

This hope was realized when the Superannuation committee of the Ontario Educational Association reported success in April 1917 saying that the new Act would prove to be "the best on the statute books of any country". This had followed a delegation of 2 500 teachers marching on the Legislature on March 9, 1917, to present their concerns to the government.

The Teachers' and Inspectors' Superannuation Act (1917), allowed any person in the Ryerson Fund to remain in that Fund or to transfer to the new Fund. It also abolished, with suitable protections, Funds established under permissive 1904 legislation by school boards which included those of the cities of Ottawa and Toronto. These boards had to continue paying pensions already granted or to provide the Fund with an amount actuarially equivalent to the cost of those pensions. In this way the boards would be out of the pension business for teachers.

The rate of individual contribution was set at 2.5% of salary (in 1936 raised to 3%) which was matched by the Treasurer of Ontario. Allowances were payable on retirement after 40 years of service calculated at 1/60 of the last ten years' average salary times the years of service. Reduced pensions were payable after 30 years of service and also after 15 years in the case of disability.

For many years the report to Fund contributors identified pensioners by sex and pension costs. Tables showed what is common knowledge i.e. that Continued on Page 27 🖾

Using Reusable Grocery Bags and Bins

any are now shopping with reusable bins, plastic bags and **IVL** cloth bags to reduce the amount of plastic they are using but it is important to prevent cross-contamination of food with bacteria that can cause foodborne illness.

The following stepscan help to prevent cross-contamination:

- Wash cloth bags frequently, especially after carrying fresh produce, meat, poultry or fish. If not machine washable, hand-wash frequently with hot soapy water. Plastic bins should be washed using hot soapy water regulary. Dry well after washing.
- Put fresh or frozen raw meat, poultry and fish in separate bins or bags from fresh produce and other ready-to-eat foods.
- Put fresh/frozen raw meat, poultry or fish in the clear bags found in produce and meat sections to prevent juices from contaminating reusable containers and other foods. Fresh produce should also be put in plastic bags;

A London Affair: A Unique Addition to the Theatre Scene presented by Brian Jarvis



Our Members Write ~ Maureen Coleman

ou may know that for a number of years, over 12 now, I have been a neuroendocrine cancer patient. A year ago I had massive surgery which saved my life. I have had a slow recovery, but thanks to my expert medical team, I do not expect to make an exit from this world any time soon. I do need very careful monitoring, however, and diagnostic scans and treatments on an ongoing basis to make sure of this.

I have benefited greatly from the Canadian Cancer Society's Volunteer driver program which helps people like me get to some of the many needed appointments. I am picked up at my door and driven downtown to Toronto General as needed, and brought back home after my appointment. I have been brought back from London, Ontario, where my specialized team is.

Some of my drivers have been retired teachers. The most recent person who drove me to an appointment and back was a retired Senior Superintendent.

The Canadian Cancer Society is currently very short of drivers and they welcome retirees who may have one or two days a week to spare. They do not mind if the volunteer driver is available only for part of the year, and they understand if the volunteer driver checks out for a month here or there. In many ways this is an ideal volunteer experience as the commitment is not a big or a constant one.

There is a lot of satisfaction in 'Giving back', and some of the CCS drivers have family members or dear friends whom they lost to cancer.

There is some training but it is not onerous, especially for a retired teacher. Would you mind sharing some or all of this info with our local retired teachers' group?

My own organization is the Carcinoid Neuroendocrine Tumour Society Canada, (CNETS Canada) but we are too small to do the kinds of things, such as driving patients, that the Canadian Cancer Society does so well. Our Vice President is retired principal **Jim Kormos**, and he is very much out and about on our behalf.

Health continued from Page 25 good sun shades, better foods and vitamins. The largest panic is when, not if, the dry eye will go wet.

Some risk factors of macular degeneration include age (increases with age), family history, ultraviolet exposure (wear your sun glasses), high blood pressure, and poor nutrition. Eye injections may be the best controlled procedure for wet macular degeneration - there is a fear factor but a good ophthalmologist with a good bedside manner does create a tolerable situation. These shots are recommended monthly. maybe for life. Not a pleasant outlook Regular eve examinations but necessary to contain the bleeding.

High levels of antioxidants and zinc may slow progression. Consult with your optometrist, ophthalmologist or pharmacist regarding which type of multivitamin therapy is appropriate

for you. Wet macular degeration has been proven to be extremely difficult to treat. Lasers have been used as well as photodynamic therapy. Be prepared for added stress and expense: travel from small communities to larger centres to visit with the ophthalmologist; spending on supplements, diet, and other items to assist in coping with the condition; driving; doing fine hand-work. All require a lot more concentration as the wet eye leaves a distorted picture which could lead to a major accident to the body.

Regular eye examinations with your optometrist or ophthalmologist are important. On your next visit, seek advice on your status for possible treatment and management.

female pensioners outlive males and so are a larger charge on the Fund. The last such regular annual table seems to have been in 1967 with figures available for 1982. Of course, in the earlier days, these larger costs for female pensions were used to counter the argument that the cost of providing pensions to widows would be unfair since such benefits would be provided only to spouses of male pensioners. A type of dependent pension was introduced in 1932 so that three years before going on pension a teacher could elect to take a reduced pension with the reduction being applied to provide an allowance to any designated dependent.

In 1946 an act provided: 1. "A" Pensions after 36 years of service provided the teacher was 65 if male and at 62 if female. After 40 years of service all teachers qualified without age restriction. The minimum pension was \$500 and the maximum \$1,500 based on entire career average salary; 2. "B" Pension with reduction factor to teachers having between 30 and 36 years of service. The minimum was \$7.00 per year of service; 3. "C" Pension in the event of permanent and total disability after 15 years of service; 4. "CB" Pension in the event of incapacity for further teaching after 15 years of service:; 5. Provision for refunds of contributions with interest.

In 1949 the new *Teachers' Superannuation Act* provided a \$600 minimum pension and, 1. "A" Pension changed to 35 years service at age 62 for both sexes; 2. A new pension after 25-30 years service at age 62; 3. Improved Disability Allowances; 4. Allowance based on 1/50 of last 15 years' salary to an upper limit of 70 % of the average subject to a maximum allowance of \$3,000.; 5. Dependents pensions were introduced for widows and children of male teachers or pensioners of 15 years or more service and for children or wholly dependent widowers of female teachers; 6. The interest on repayments of refunds was cancelled; 7. When the payments into the fund in any year are insufficient to make the required payments out of the fund, the deficiency shall be made up out of the Consolidated Revenue Fund".

The maximum limit on pensions was removed in 1953. In the following year the calculation was changed to the best ten years and those pensions granted prior to 1954 were recalculated.

The last vestige of sex discrimination was abolished in 1971 when widowers of pensioners were made eligible on the same basis as widows for dependents allowances. It was only in 1983 that the stopping of such allowances (now called survivor benefits) was abolished when the recipient remarried.



As you may have noticed, the format of our Newsletter has been modified to make better use of the colour cover; put administration items in one place; and, generally tidy up the eve-appeal.



RTO/ERO Acknowledgement, Waiver & Release

RTO/ERO demands that Districts be advised that the waiver and/or reference to the waiver should accompany all advertisements for trips and special events as follows:

It is acceptable to publish the waiver in a newsletter or on the District web site and to have each participant sign on the registration form that s/he has read and has agreed to the statements in the waiver. The signature cannot be on a blanket form i.e. for unspecified trips/ events over a period of time. Where there has been an incident, the District Executive should consult with the Director of Financial, Business and Building Services at the Provincial Office about how long waivers should be retained.

RTO/ERO provincial committees guide the organization in developing and maintaining services to members. Members are encouraged to communicate on any matter within their purview. You may do so directly as an individual or you may seek the support of your District. District executive structure parallels that of the provincial committees. Note: the Constitution was changed (2009) to allow the Health Services and Insurance Committee to avoid being responsible to Senate regarding the RTO/ERO Benefits.

Audit Committee

- oversees RTO/ERO's financial reporting process;
- reviews scope of audit and audit plan with external auditors;
- reviews internal financial controls:
- reviews audited financial statement with the external auditors.

Communications Committee

- recommends the type of communications, including website; advertising and editorial policy; and practices related to publishing letters to the editor;
- assists districts in local communications (newsletters, websites).

Health Services and Insurance Committee

- oversees the operation, administration, interpretation and application of the RTO/ERO Health Insurance Benefits Program;
- appoints insurance carriers, underwriters, administrators, claims payer, consultants, and other professional help;
- oversees the Benefit Entitlement Review process (see Page S5).

Member Services Committee oversees or assists:

- Emergency Assistance (see Page S23);
- District Goodwill Programs
- Travel Programs (operated by Merit Travel, see Page S23);
- Membership Recruitment (includes Retirement Planning Workshops).

Pension and Retirement Concerns Committee

- responds to concerns of retired teachers re pension entitlements;
- recommends amendments to the Teachers' Pension Plan Act benefitting RTO/ERO members and active members of the teaching profession;
- maintains liaison with organizations in the field of gerontology;
- monitors government legislation in the field of pensions, taxes, health, accommodation and social services;
- keeps members informed about significant issues/developments that affect retired teachers through topical Fact Sheets and the development of articles for Newsletters;

• monitors the operations and investment strategy of the OTPP.

Political Advocacy Committee

- spearheads political action on behalf of seniors and retired educators in anticipation of Federal and Provincial government initiatives;

Project - Service to Others (STO) Committee:

- recommends criteria used and the types of Service-to-Others (STO) projects to be approved for grants (see Page S13);
- determines which STO Grants are to be approved and the amounts;
- reviews/recommends Scholarship Applications (see Page S22);
- recommends to Senate any changes to STO Grants and Scholarships.

Health Benefits Premiums ~ 2012

- Benefits and rates were effective January 1, 2012 (to be revised 01/01/2013);
- The provincial portion of the HST (8% in Ontario) or the provincial PST (9% in Quebec) is added to monthly premium rates.
- See Page S5 for guidance on making suggestions for benefits' change in 2014. (Suggested changes for 2013 are now being costed and those deemed cost-effective will be made known in December, 2012.)
- The deadline for the submission of claims is the end of the calendar year following the year in which the expense was incurred. If you have any claims not submitted for 2011, they must be submitted to Johnson Inc. by December 31, 2012.
- Booklets are reprinted every three years. The next distribution is scheduled for early 2014. Keep your annual Group Benefits newsletter with your booklet. Premiums, and the difference between the amounts submitted and amounts reimbursed, may be eligible to claim on your Income Tax. Statements of Premiums and Claims summarizing the premiums paid, along with the total claims submitted and paid in the previous calendar year, are mailed to vou in February. Remember to submit these to whomever does your taxes.

How Our Health Plans Are Developed

nly the Health Services and Insurance Committee (HS&I) determines the benefits that our health plans provide for the rates paid. Balancing affordable premiums and optimal coverage, the HS&I Committee annually examines the current usage of the plans; receives input from individuals, districts and Senate regarding plan modifications; then determines coverage and rates for the following year. (In 2009, the Constitutional requirement to report changes in coverage and premiums to Fall Senate for amendment or approval was removed.) Benefits changes begin January 1. Premium changes are effective the preceding December.

If an individual member or district wishes to suggest a change in the plans for 2014, it should be presented to the Health Services and Insurance Committee by March, 2013. Present vour case to the committee at:

RTO/ERO Benefit Entitlement Review

an participants who contact **T** RTO/ERO after a claim has been denied will be directed to a claims specialist from Johnson Inc. to discuss the rationale of the decision. If the participant does not agree with the reason from Johnson Inc. and contacts RTO/ERO again, the participant will receive an application letter from RTO/ERO.

This letter describes process and contains a form that the participant completes and submits to RTO/ERO. The participant would be required to specifically indicate that the claim should be approved based on the fact that at least one of the three criteria is applicable. Forms are returned if they do not clearly identify at least one of these criteria.

Upon receiving the form and any other pertinent information, RTO/ ERO will keep a copy and send originals to Johnson Inc. Johnson Inc. will do an independent review of the claim with the adjudication of the benefit entitlement measured against the three criteria. Johnson Inc. will notify the member if the denial was upheld or overturned.

Johnson Inc. reports individual request through our District Health reviews/outcomes to the HSIC. If the HSIC determines that a review was not handled as it should have been and that any of the three criteria did apply, then HSIC would provide Johnson Inc. with direction applying to all future claims.

Travel Insurance Reminders

Caveats

- Point Program Redemptions of any type (e.g. Air Miles) used to purchase travel are not covered.
- Trip Cancellation/Interruption Benefits are subject to the same exclusions and limitations as all other insured benefits plus others (check your Out-of-Province/ Canada Travel Booklet).
- You must be in your province-ofresidence when your trip begins. (Trip cancellation only applies before you leave your province of residence.)

af you are outside North America, • Obtain access numbers to Canada; Lor in a country that does not participate in Universal International *Toll Free*, dialing Canada procedures can differ depending on the country.

Canada's country code is 011. *In* countries where you can dial direct using the Canada code, dial 011-1-915-742-6683

to reach Allianz Global. Other countries may require dialing other numbers (i.e. 090 or 000).

Procedures also depend on the location from which you dial. Many resorts do not allow dial-direct or use of international calling cards from your room and their per-minute charge can be expensive.

Pay phones may also be restricted in tourist areas

If travelling in a country not listed in RTO/ERO's booklet, you can contact Mondial Assistance to determine the best way to reach home. Your travel agent should also be able to assist.

Canada Direct

If your home Canado telephone provider (Bell, MTS, Aliant,

Sasktel, or Telus) participates in the CanadaDirect plan, you can use a separate toll-free number to reach an operator and be connected to your party in Canada. This automated international access service (routed by Teleglobe Inc.) allows you to call home without going through a local operator. With Canada Direct you can:

- Rapidly reach an English or Frenchspeaking Canadian operator;
- Charge calls to your Calling Card or make Collect Calls;
- Pay Canadian international long distance rates instead of the rate of the country you are calling from;
- Avoid potential language problems;
- Be billed in Canadian dollars.
- · Access numbers are updated regularly. Call 1.800.561.8868; check your telephone book; or, www.infocanadadirect.com

Remember:

- there are time-zone differences:
- it may take 45 seconds or more for an overseas phone to ring;
- overseas rings and busy signals often differ from those in Canada.

Cellphone Usage

Using your cellphone outside of North America (or even Canada) depends on several factors: the phone technology: the cellular provider; whether the region you're in has cellular service; and, the type of contract you have. A cell phone that does not use a particular technology is unusable in Europe no matter which cellular plan you may have. Roaming rates can be several dollars per minute, plus the cost of cellular long distance and, turn off your data services. A good idea is to contact your cellular provider prior to travel and consider discontinuing (or at least not using) vour data-service.

Pocket Planner ~ annually produced and mailed to all members in late Fall (mid-July in 2012). The general format has been used for a number of years with minor modifications as suggested by members. Its design permits ease of use for purse or breast/suit pocket.

Position Papers ~ created for political advocacy by local district members and Political Advocacy Committees. These positions of RTO/ERO, available in PDF or Word format from our websites' Political Advocacy link. There is an emphasis on matters related to older citizens.

Renaissance Magazine ~ a *quarterly* publication mailed directly to all members; distributed twice/year to all Ontario schools. It is the official Magazine of RTO/ERO now available by subscription through emailed PDF should one wish to conserve the environment.

Project STO (Service To Others) Grants

RTO/ERO proudly operates a grant program for its 47 Districts, providing \$100,000 to sponsor local community projects. Through Project – Service to Others (STO), Districts apply for individual projects that support local, national and international programs that often involve children and/or disadvantaged groups, to a maximum of \$4,000 per project.

A provincial committee of RTO/ERO assesses the merit of each Project – STO submission according to established criteria, including level of member and District participation in the project.

Examples of types of projects receiving funding include: local heritage and culture projects, special arts and education programs for children, support for initiatives in developing countries, literacy and numeracy programs, and school day care for the children of single teenage mothers.

Our list of previously approved projects is testament to the value and success of Project – STO, as well as a good resource for ideas on the diverse selection of projects that receive funding.



Applications are reviewed anonymously by the Scholarship Committee on or before September 30. Successful applicants are typically notified on or before October 31

Membership

Most of our members are retired teachers from Ontario Public, Catholic and Designated Private Schools receiving a pension from the OTPP.

However, the following are also potential Full or Associate members:

- retired non-educator employees of an Ontario School Board or educational organization (e.g. CUPE, employee associations, etc.).
- individuals not retired and eligible to be Full/Associate members on retirement;
- retired educators receiving a pension from a non-designated Ontario Private School:
- retired teachers who opted for a deferred pension from the OTPP;
- retired teachers who opted for the commuted value of his/her contributions to the OTPP:
- surviving spouses of Full/Associate members;
- retired educators receiving a pension from the Ontario Public Service or the equivalent from a Canadian jurisdiction outside Ontario;
- retired educators receiving a pension from a University or College in Canada (administrators/faculty/staff of Colleges and Universities);
- retired teachers receiving a pension from a teachers' pension fund outside Ontario
- non-educator divorced spouses of Full or Associate members;
- * The Ontario Government now permits teaching beyond age 65. Since they may need medical coverage they will be permitted to join RTO/ERO. Also, should they wish to participate in our Long-Term Care Plan, premium rates are lower for those contributing longer.
