In recent travels to three European countries I experienced the heightened security in all airports. As I submitted to

the extra searches and beeped every time I went through the portals, I kept thinking: "Do I look like someone suspicious?"

My carry-on was searched several times, but all I had was the regular items: book, toothbrush, passport, tickets, etc. Finally, in the Oslo airport, a kind security officer asked: "Do you wish a female officer to search you?" Relieved, I answered, "Please and thank you." After much phoning, they could not locate a female officer and decided I was not much of a threat. By then, the officers had determined that it was my amber silver bracelet that set everything beeping. Travel advice: Do not wear jewellery when travelling.

The visit to my country of birth, Denmark, brought into focus the economic conditions in Europe. I observed the many "For Sale" and "For Rent" signs. From family and friends I learned that many young people, despite excellent education, cannot find suitable jobs. In addition, the media are filled with stories of all the refugees from the war-torn middle east streaming across borders seeking safe countries. It is so bad that the government could not find suitable accommodation for the refugees. These numbers have not been this high since the Second World War.

No doubt that we, as Canadians, are lucky that our economy is holding its own. We are a country of immigrants who work hard to have a strong democracy with a strong set of values.

Arriving in Toronto, I breeze through the self-clearing immigration hall and am met with a smile as I tell them I have nothing to declare. The last I hear is "Welcome Home" as I pass through the doors to my waiting children.







t its September and October meetings, your Executive:

received information that the Travel Industry Council Fict Sixtee of Ontario (TICO) has served notice to RTO/ERO that travel programs organized by districts for members and their friends must be

arranged via a TICO-certified travel agency. (See Pages 4, 25, 26 and S2); • received notice from Jack DeGroot, our Day Trip Convenor, that he and

- Linda Grieve will no longer be able to organize Toronto District trips under the new protocol. (See Pages 4, 25, 26);
- agreed to honour Jack DeGroot at the 2015 AGM;
- agreed to investigate and re-establish as soon as possible an alternative day-trip opportunity through John Bratton, our Executive Travel Chair;
- received notice that the Service-to-Others Award, as recommended by your executive, was granted in the amount of \$3,100 (see Page 29);
- approved a motion for Fall Senate to seek clarification, in more detail, regarding the medical stability clause for travel as to the rationale for, and the restrictions related to, this clause and have this information included in a future issue of Renaissance;
- agreed to purchase up to 12 RTO/ERO Golf Shirts for the Super Tees participants at a cost of approximately \$360;
- donated \$1,000 to Global Medic's efforts to fight the Ebola spread;
- received the treasurer's report to 4 October 2014: Assets/\$72,242; Budget/\$65,830; Expenses-to-Date/\$50,199.94;
- approved a motion to Senate to extend Full Membership to Associate Members

-he Annual Meeting of RTO/ERO (Fall Senate) was attended by Toronto representatives: Roger Wilson, Roy Harvey, Joan Elliott and Bill Menagh. Our Newsletter Supplement provides some detail of the business. Below is a Since 1968 summary of the decisions made:

- a) the full-membership fee is maintained at \$1.25/\$1,000 of OTPP pension (paid once per annum deducted from the January pension payment).
- c) adjusted the Associate Member fee to the average fee paid by Full Members (paid once per annum by personal remittance);
- b) constitution changes implemented to protect RTO/ERO reserves and Health Plan reserves by requiring both notice of motion and enriched vote (you may recall our previous Newsletter concerns regarding the sudden motion at Fall Senate, 2013 that, in our opinion, wrongly donated \$3,000,000 to the RTO/ERO Charitable Foundation from these funds);

## 2015 OTPP Inflation Adjustment\*

four pension includes annual cost-of-living increases to help you maintain buying power throughout retirement. The 2015 inflation adjustment, which will take effect in January, is 1.7%, almost double the 2014 adjustment of 0.9%.

The adjustment is based on 100% of the increase in the Consumer Price Index, a weighted basket of goods and services typically purchased by Canadian households each month. The method used to calculate the increase is prescribed in the Teachers' Pension Plan and is the same method used by  $\frac{1}{2}$ most other major Ontario Pension Plans, as well as the Canada Pension Plan.

most other major Ontario Pension Plans, as well as the Canada Pension Plan. In April 2014, the partners announced a \$5.1 billion funding surplus. This surplus is being used to partially restore inflation protection for pension credit earned during 2010 to 2013.
If you retired before 2010
You are unaffected by the decision on how the surplus funds are being spent because you receive full inflation protection. For example, if your annual pension is \$40,000, it would increase by \$680 beginning in January.
If you retired between 2010 and 2013
First, your pension will be restored to the level it would have been if full inflation protection had been provided for the portion of your pension earned during 2010 to 2013. After this one-time boost is applied to your 2014 gross pension, your 2015 inflation increase will be based on two components:
Your pension based on pre-2010 credit receives the full inflation adjustment.
Your pension based on post-2009 credit receives 60% of the full inflation adjustment (1.02%).
If you retired in 2014

## **RTO/ERO Toronto Commemorative Tree**

#### **Ravines** ~ the Wild Side of Toronto

"The awe of a wildflower attracting butterfly and bee The Resonance of a bubbling creek The joy of a toddler scampering at dawn Beaver Trails on the way to China and Eldorado The call and reprise of Hogtown's Wildside The Hidden Secrets of Ravine Toronto"



Toronto was bequeathed with over 26,000 acres of ravines by the various ice advances that shaped the Southern Ontario landscape over the past million years. Long before glaciations, giant deer (Cervalces) and other large mammals (woolly mammoth) roamed. After the last glaciers receded some 13,000 years ago, the native peoples arrived with their Ojibway/Algonquin culture. Ravines and their rivers alongside Lake Ontario were the waterways and pathways that they used. They paved the way for European settlers and, by sharing their cultural ways, enabled the early pioneers to survive the harsh winters. Some of the early settlers thought Toronto was a stopover on the way to China and El Dorado!

The pioneer ethos, over time, impacted on Toronto's ravines and waterways. Resource extraction gave way to rural development, displaced inevitably by an emerging urban/industrial landscape as Toronto grew as a major urban centre. It followed that rail lines, oil pipelines (Line 9), roadways and deforestation, combined with various sources of pollution, both rural and urban, significantly altered and stressed the ravines and their waterways.

Then came hurricane Hazel in 1954, an unprecedented storm that turned the ravines into raging, monstrous vehicles of destruction. Homes and bridges were destroyed - 81 lives were lost. Human occupancy had been placed in a deadly path. However, an intelligent response was forged in the creation of the Metropolitan Toronto Conservation Authority. Land use control was established in all ravines. No longer would people live on the flood plains. Flood control and ecology measures were implemented, beginning in the 1950's just in time to save the ravines that we enjoy today. Despite the

impact of the recent "Polar Vortex" on the tree and brush canopy, wildlife in our ravines is thriving. The Conservation Authority, wildlife conservation clubs, ordinary citizens, and some of our elected officials have acted as ongoing ravine stewards fostering a four season recreational resource and priceless conservancy. *Cont'd Page 16*

In winter, white tailed deer, cardinals, over-wintering robins, chickadees, woodpeckers are a common sight. Pond freeze-overs are criss crossed by coyotes, foxes, possums, raccoons, deer or off-leash dogs. Skis and snowshoes are dusted off and used as cross country trailblazers. The occasional ice skater ventures forth on solidly frozen ponds, under which turtles and frogs are hibernating.

Springtime welcomes trout into the healthier rivers and streams. Swallows and songbirds beat a fast flight north and settle in to starting new families. Cottontail rabbits venture forth as coyotes and foxes chase them for lunch. White tail deer fawns follow mother does into deeper brush, while reawakening turtles enjoy a sunny break on a log and peeper frogs compete in chorus at dawn and dusk. Snakes emerge from hibernation as the sun warms up the ravine landscape.

Bush parties and off trail bike rallies merge and wildflowers dot the landscape, as monarch ladies seek milkweed. Youth swing off wild vines like Jungle Olympians as summer arrives. Fun, fresh air and BBQ enjoyment gladden the eye and the soul. Summertime echoes with the chorus of growing young birds, turtles, rabbits, frogs, bees, swallowtails, spiders, mosquitoes and preying manti. Ravines are alive with green verdure as hikers, cyclists and walkers enjoy the great outdoors.

Fall is marked by a rainbow of colours over the tree canopy. Spectacular Atlantic and Chinook salmon run in clear rivers and creeks. Beavers hurriedly stock up on winter food prior to freeze-up. The woolly-bear caterpillar migration marks the upcoming onset of winter as the ravine year turns full circle. Wildlife stragglers, such as raptors, migrate south. Others scramble to hibernate, or seek shelter, including talkative cardinals, blue jays alongside their crow cousins, and the rare mockingbird. Except for nearby jet planes and railway trains and gurgling waterways, ravines grow more silent. Daylight dims as the Polar Vortex comes calling on Toronto's ravine doorways. What a treasure!


(Our Resident Expert On Things British)

Chester, England was a Roman fort with routes laid out almost 2,000 years ago and which modern main roads still follow. Of course, the Industrial Revolution brought expansion and development, including a major rock salt mining industry around four "salt towns" in Cheshire.

Nearby is The Pontcysylite Aqueduct, which is navigable and carries a canal into Northeast Wales. Completed in 1805, it is the longest and highest aqueduct in Britain and a World Heritage Site.

The Anderson Boat Lift, Scheduled Monument, built in 1875, was in use for over 100 years before being closed due to corrosion in 1983. It reopened in 2002 and is one of only two working boat lifts in the UK - the other one being in Scotland.

#### Pensions, Birthdays, Travel and the Law

From time-to-time legal issues impose themselves on other matters close to the heart of RTO/ERO members. On Page S13 we reference adjustments made to Canadian pension plans, including OTPP and OMERS, because of changing societal norms. In this case, although a cost to the pension plans, the overall benefit provided is considered the greater good.

As to birthdays, RTO/ERO has been in the habit of providing local Districts with the birth dates of our members. This information permitted the Districts to tailor some of their activities to specific members: e.g. centenarians and special events for those of a specified age (in our case, we treated our 75-year-olds as guests at our AGM and Spring Luncheon). As Canadian privacy legislation states that RTO/ERO must protect the privacy of its members' information, the Provincial Office can no longer provide us with a member's specific birth date, i.e. year of birth, month and day, without a member's permission. We will be provided with a list of those members reaching a special birthday such that we may be able to continue past practice.

Of recent consequence is the Travel Industry Council of Ontario's (TICO) communication to RTO/ERO stating that the travel opportunities offered by local Districts to members and friends must comply with government legislation, monitored by TICO, that states that the transportation and accommodation aspects of any trip must be arranged through the services of a TICO-certified agent/agency. (Page S2: Provincial President's Report)

The Travel Industry Council of Ontario (TICO) is a self-managed, not-forprofit corporation, responsible for administration and enforcement of the Ontario Travel Industry Act, 2002 and Ontario Regulation 26/05 on behalf of the Ontario government. The legislation governs all of the approximately 2,500 travel retailers and travel wholesalers registered in Ontario. In addition, TICO administers an industry-financed Travel Compensation Fund. TICO was established in 1997 as a delegated administrative authority under the Safety and Consumer Statutes Administration Act, as a result of the mutual desire of the government and the travel industry to enhance professionalism, increase consumer protection and provide an effective and efficient regulatory body. The Ministry of Government and Consumer Services continues to be responsible for the Ontario Travel Industry Act, 2002 and Ontario Regulation 26/05 as well as general oversight of TICO.

- a \$10,000 fine for each situation not appropriately booked;
- RTO/ERO volunteers organizing District trips that are contrary to the Ontario government (TICO) regulations may face personal liability claims.

Black Creek Community Farm Plack Creek Community Farm: a place where students Can build on what they learn in the classroom, put on their rubber boots, get their hands dirty in the process of learning about how their food is grown and raised, and experience first-hand how we are all interdependent. The farm is dynamic and exciting. It is a beautiful 7-acre property in an extremely dense urban setting with over 7500 K - Grade 12 students within walking distance.

When people of all ages arrive for the first time at Black Creek Community Farm, their reactions are very similar. Who, how, and just what, is this place? How is it possible that a farm can be here? They are surprised, and then excited with the realization of the farm's potential; and they are often moved by the tranquillity and peace that the land gives them.

Funding from RTO/ERO opens up a world of possibilities for more engaged learning that has the potential to be life-changing for low-income urban youth. This support demonstrates that RTO/ERO is an organization that is contemporary, relevant, and committed to community awareness and growth. Our members, volunteering in places such as this, show potential RTO/ERO members that we still make a real difference in students' lives.

A production farm in an urban landscape attracts attention. Growing spinach in the city turns heads. The gates of the farm have only been open for one season, yet the media coverage has been astounding. The farm has been highlighted on CBC's Metro Morning with Matt Galloway several times, has appeared in all regional and local papers, and was given the spotlight on the front page of the Toronto Star last fall.

Growing food is very exciting, yet the reason for the media attention is the community approach to the farm. The farm is an intergenerational place of learning and training. Involvement from retired teachers will be highlighted and celebrated. Visitors to the farm will have the unique opportunity to see RTO/ERO members involved in the activities mentioned above.



## RTO/ERO Acknowledgement, Waiver & Release

RTO/ERO demands that Districts be advised that the waiver and/or reference to the waiver should accompany all advertisements for trips and special events as follows:

It is acceptable to publish the waiver in a newsletter or on the District web site and to have each participant sign on the registration form that s/he has read and has agreed to the statements in the waiver. The signature cannot be on a blanket form i.e. for unspecified trips/ events over a period of time. A District may list a number of events on one page, but each participant must sign off against each trip/ event in which s/he plans to participate and must sign off on having seen and agreed to the waiver.

It would be prudent that Districts include advice to participants in any trip/event that requires physical activity/effort beyond what they ordinarily exert. *Participants should be advised to consult their doctor especially if they have a pre-existing condition that raises concern.* 

Districts should retain signed waivers for one year in cases where nothing untoward has occurred. Where there has been an incident, the District Executive should consult with the Director of Financial, Business and Building Services at the Provincial Office about how long waivers should be retained.

RTO/ERO advises prudence 'for participants in any trip/event that requires physical activity/effort beyond what they ordinarily exert. Participants are also advised to consult their doctor, especially if they have a pre-existing condition that raises concern.'



Editors' Note: The Fall Senate (Annual General Meeting) of RTO/ERO is held in mid-October. This meeting determines RTO/ERO's 2015 initiatives and budget allocations. Our November Newsletter is used to inform you of some of the details of RTO/ERO's business. We believe that members should be aware of the business if only to understand that RTO/ERO is more than just an insurance source. # Provincial Executive (PE)

The Provincial Executive has been involved not only with its regular oversight of the implementation of priorities, the performance of investments of our Reserves, and visitations to Districts, but also with the Ad Hoc Committee re travel reimbursement and the revision of the travel guidelines arising from the TICO inquiry.

Included in this Agenda is a report on the sensitive issue of the potential outcome of negotiations between the Provincial Government and the Affiliates with respect to the management of health plans for school board staff, and how to ensure RTO/ERO's ongoing access to those

staff about to retire. It is important that all those attending Senate give this report due attention.

Among significant achievements to date are:

- The delivery of provincial workshops for District Presidents; District/Unit Health, Communications, and Member Services Representatives;
- The introduction of Eldercare Select;
- A more dynamic marketing strategy for the RPWs (Retirement Planning Workshops);
- Funding for the establishment of a Chair in Geriatrics at the U of T.

# President

**Z**am proud that RTO/ERO owns and operates a Group Benefits Program, the largest voluntary retired educator insurance program in Canada with over 87,000 insured members and their dependents.

I am pleased to report that during the provincial election campaign, we were able to meet **Premier Wynne** informally. We expressed again RTO/ERO's interests as they relate to retired teachers, and the possible outcome of Government/Affiliate negotiations and the impact on RTO/ ERO's access to retiring school board staff.

As most of you would know, RTO/ ERO's long standing Executive Director, Harold Brathwaite, is retiring in July 2015. We are in the

process of looking for Harold's replacement.

After the Spring Senate, there was a request to form an Ad Hoc Committee to Review Travel Expense Guidelines. [Some Senators wish to be reimbursed for mileage even if flying were cheaper.]

We have had many questions about travelling by members. In the past, RTO/ERO volunteers would organize trips on behalf of Districts. Not so anymore. Any trip that involves transportation and/or accommodation is governed by TICO's regulations and thus must be organized by a TICO-certified travel agent. Any District or any individual that/who ignores the revised Travel Protocol and is found by TICO to be in violation of the law will be personally liable for any penalties or costs arising. So I would urge you and your District to follow the RTO/ERO

 $\sigma$  or the edification of those who may be wondering what the Provincial Office has been doing since the Spring Senate, here is a sample: organizing three workshops, monitoring and taking appropriate action re various pieces of legislation on accessibility, privacy, health & safety, and notfor-profit corporations, travel policy revisions due to TICO intervention, follow-up to last Senate re travel reimbursement Ad Hoc Committee, hires. three new in-service re investment options for the Provincial Executive, preparation of 2015 Draft Budget, meetings with architects re the building at 18 Spadina, meetings with IT firms re possible Client/Customer Relationship Management (CRM) solutions, and 23 days qf Provincial Executive and Committees meetings. Not to mention the hundreds of emails and phone-calls staff receive and respond to daily in addition to their other regular duties.

We have added three new staff to RTO/ERO office. This does not include Foundation staff. Both our new receptionist, **Francine Viau**, as well as the new and third member of the Health and Benefit Services team, **Eliza lves**, are bilingual. Eliza had previously worked with us in a temporary position. We finally

revised Protocol that was recently sent to each District President. We will ensure that there are ongoing reminders of this responsibility.

have two full-time staff in IT with the hiring of a new IT Manager, **Charles Tabone**. I expect Charles and **Marzena Wspanialy** will make a significant difference in moving this organization forward in its services to members over the next 18 months.

Included in this draft budget are funds for one more staff member in 2015. However, I will leave it to my successor to determine the nature of the hire. I reiterate that none of the senior staff, myself included, has an assigned administrative assistant. The new Executive Director may indeed require such support. Another area of expertise this organization will require in near future is someone with a Human Resources background to ensure ongoing compliance with legislation, appropriate management the of records, the training and support of staff, and limit risk to the organization.

Over my 10 years with RTO/ ERO, I have twice initiated the reorganization of our physical space in order to accommodate more staff. There are currently two available cubicles, but there is no more room for further expansion. Moreover, the joint lunchroom and kitchen space is inadequate for our current complement of staff. Sooner, rather than later, a *Continued on Page S4*

decision will have to be made about how to meet the future growth of our operation. We have been a lean operation now with 21 staff serving our 71,000 plus members, but ongoing effectiveness and the need for a comfortable, pleasing workspace must always be a priority if we want to keep high quality staff.

In the immediate future, our IT Department, working in collaboration with senior staff, will review all of our business processes with a view to implementing a Client/Customer Relationship Management software system in 2015. This will ultimately lead to a complete reworking of our website to make it more easily accessible by all members.

I cannot overstate the fact that we continue to serve our 71,000

### **Budget Proposal for 2015**

The structure of 2015 proposed budget is modelled on the May 2011 approved *re-allocation of assets* to Districts and to the Provincial Office. There are some small rearrangements of some budget lines with a view to making comparisons from year to year easier to follow, and these are clearly identified.

The guiding principle of successive Provincial Executives as well as of senior staff with respect to the Annual Budget review and preparation has been to seek to enhance quality service(s) to members while maintaining modest expenditures. **So again in 2015 the membership** fee of \$1.25 per thousand dollars

members in an exemplary manner and that is often reflected in the feedback from Senate and from the workshops. In addition, almost every week one or more staff member(s) receive written compliments about their professionalism from members. In addition, successive Provincial Executives have provided a sufficient level of oversight and caring in their relationships with staff and this is valued.

In the last few weeks I have become conscious of the fact that as an organization we are moving into a period of transition and, next year at this time, my successor will be addressing you. I will do my best to ensure that the transition is seamless and positively impacts our entire community of members and staff.

Although we are proposing to increase the staffing level by one person in 2015, any comparison of the staffing levels at RTO/ERO with other professional teacher groups in the Province will show that ours is the most cost effective.

The proposed budget for 2015 is based on the following assumptions:

- a) Net increase in membership in 2015 - 2.1% or about 1,500 members
- b) Projected January 2015 inflationary adjustment in teachers' pensions - 1.6%;
- c) No increase in RTO/ERO Full

  - a. 27% of the membership fees allocated to the Districts (estimated at \$13.91 per member);
  - b. Minimum Grant \$10,978

c. Additional subsidies for the Size, Distance and Density factors added to the Annual Grant making a total of 30% of membership fees allocated to Districts.

The 2015 Budget projects an increase in total revenues by \$262,600 or 3.8% over 2014 Estimate. The increased revenue is due to the increase in RTO/ERO membership and the growing number of RTO/ERO group plan participants.

# **Communications**

Our mandate and our committee priorities remain the same: to assist as much as possible, those in our Districts who are responsible for communication with our members. We will continue supporting District Webmasters, Newsletter Editors and District Communications Chairs. We shall, though Committee professional development workshops, continue to become familiar with emerging methods of communication as well as enhancing our understanding of traditional means of mass communication.

#### Laurie Fountain, Chair 66 Constitution

The mandate of the Committee is to receive proposals for changes in the Constitution, Bylaws and Policies from the Senate, Provincial Executive, Districts, Standing and Executive Committees. The Committee may initiate change to the Constitution, Bylaws and Policies.

The Committee met in February, April and September. The following has been accomplished:

- Reviewed five of the District Constitutions.
- Reviewed resolutions passed at the Annual 2013 and Spring 2014 Senates.

• Reviewed the evaluations from the Spring 2014 Senate.

- Compared Sturgis Standard Code of Parliamentary Procedure with Robert's Rules of Order and unanimously is in favour of retaining Sturgis for RTO/ERO.
- Studied matters coming to the Annual 2014 Senate *and advised the PE as appropriate.* [We assume no attempt to bias discussion.]

• With the Provincial Executive, studied the agenda and content of the meeting of the 2014 Fall Senate in order to prepare effectively.

### **Review Of The Claims And** Administrative Procedures Of Johnson Inc.

The HSIC has just received this review and will be meeting in September with representatives of Manulife Financial (MF). At this time MF confirms that "Overall Manulife Financial is satisfied with the off-site and on-site audit results as outlined in this audit summary".

Although the details are proprietary, the objectives of the Review were:

- To ensure appropriate controls are in place with respect to the administration of current and new business Obtain assurance that enrollment records are accurate and coverage for Plan Members is maintained and updated appropriately.
- To ensure appropriate controls are in place to ensure the accurate payment of claims.
- To ensure the coding on the Johnson claims payment system matches the Plan Sponsor contract.
- To ensure appropriate financial controls are in place with respect to storage of cheque stock, issuance of

cheques, bank reconciliations and appropriate back ups etc.

- To ensure appropriate hiring practices and training programs exist.
- To ensure that accurate premium remittance is in place for all benefits under the plan.
- To validate services and agreements in place for Third party Providers.
- To perform a Security Risk Assessment.

#### Claims Service Enhancement: Fall, 2014

Currently, the large majority of claims for drugs, dental, vision,

physiotherapy, chiropractic, massage therapy, naturopathy and acupuncture can be submitted electronically through the member's provider. The advantage to our members is reduced out-of-pocket expenses.

In the fourth quarter of 2014 Johnson will make available the ability to accept a claim submitted online directly from the member.

The option will still be available for members to submit paper claims, but this change is in keeping with the movement of the health insurance industry toward more web-based administration capabilities.

# Ad Hoc Reports

#### n Marketing

O The Ad Hoc Committee on Marketing reports to the Provincial Executive. It is composed of members of the Executive, staff of RTO/ERO and Johnson Inc. (JI) and the Chair of the Health Services and Insurance Committee. Its mandate is to develop a joint marketing initiative for the RTO/ERO Group Benefits Program for implementation this year.

The Committee determined that the best avenue to market RTO/ ERO's Group Benefits Program was through our Retirement Planning Workshops (RPWs). In coordination with these RPWs, JI has offered the following for every RPW throughout 2014, and into early 2015 for those Districts that did not receive this in early 2014:

- 1. Every prospective RTO/ERO member who attends an RPW will receive a \$20 gift card for Tim Horton's.
- 2. There will be a draw for an iPad Mini at each RPW.

In addition, we jointly developed an online enrollment utility for our RPWs. This registration method:

- 1. Helps RTO/ERO to engage with a younger population.
- 2. Reduces the workload of the District organizers by ensuring that they receive all of the information they need -the first time.
- 3. Enables RTO/ERO to track

attendance and better project for future workshop requirements.

#### **On Succession**

The Ad Hoc Succession Committee has been in place for two years. This Committee was formed for the purpose of finding a replacement for the current Executive Director who is retiring in 2015.

The goal is to conclude the process by the end of March 2015.

# Pension & Retirement Concerns (PRC)

#### Detirement Concerns

Five Fact Sheets have been updated and reposted on the RTO/ ERO website while five more are in the process. About 24 will be addressed next year. The Committee decided to take no action at this time on the possible Fact Sheet dealing with grief.

#### Communications

The Committee continues to consider ways of using webinars as a method of disseminating information with Districts. The Ontario Teachers' Pension Plan (OTPP) website is being investigated as a possible source of existing videos that can be accessed by Districts and individuals. This website is comprehensive. We hope to provide direct guidance to our District Representatives to access some of the valuable information on the site.

# Political Advocacy (PAC)

### **Pension Concerns**

The Committee held a meeting at the OTPP offices. We were updated on IT innovations including the mobile device app to track the number of days taught by occasional teachers. We learned about the process of how investments are made from the research stage up to the actual purchase. This process includes numerous checks and balances that ensure the integrity of the Plan.

We learned why OTPP receives such high ratings for service to members. The staff is highly trained, highly educated and highly motivated.

If approved by Senate, a workshop for District Representatives will be held in 2015 to understand and support defined benefit pension plans based on the OTPP specifically and other Ontario pension plans in general. **David Cornwall**, Chair

### Project ~ Service to Others/Scholarships (STO)

Trior to meeting in September committee the L individually reviewed each application as is our custom and, using our scoring sheet, rated each application. When we met as a full committee we reviewed every application and determined the amount of money each application would receive. It was determined that, in some cases, less than the requested amount would still provide substantial support and also allow for more projects to be funded. This year we approved total funding of \$91,800 to fully, or in part, support 31 of the 33 projects that were submitted for consideration. A list of

# **OTPP Benefits Adjudication (BAC)**

An appeal hearing, scheduled for September, was cancelled because the parties were able to reach an acceptable resolution at a Case Conference prior to the hearing date. The original appeal was launched to determine "what constitutes pensionable salary".

The BAC hearing panel for the November appeal determined that a member cannot backdate termination or resignation dates. A pension can only commence after a member is no longer 'employed in education'. The panel rejected the appeal and upheld the original resignation date that The Ontario Teachers' Pension Plan (OTPP) had implemented.

#### Changes to the Plan

Sections 84 and 106a of the Plan were amended effective January 1, 2014. These amendments allow (OTPP) to pay a commuted value of a small survivor benefit in a lump sum rather than a small monthly pension. If the member's pension commenced prior to July 1, 2012, consent is required to pay in a lump sum. In general terms, *Continued on Page S14*

if the commuted value of the pension is ten thousand or less, a lump sum payment will be made.

Paragraph 27 of the Partners' Agreement was also amended effective January 1, 2014. This amendment allows a Director to remain on the Board for five consecutive terms when the initial term was to replace an existing director mid term. Previously, directors were limited to four consecutive terms (eight years). This amendment also applies to committee members serving in other capacities with OTPP.

#### Pension Law/Regulatory Update

Bill 151 proposed amendments to sections of the Pension Benefits Act that dealt with spousal entitlements to death benefits. The Ontario Court of Appeal determined in the Carrigan case that the death benefit must be paid to the named beneficiary (if any) or to the estate. If a member dies prior to retirement and is both married (but living separate and apart from the married spouse) and has a common law spouse, the original spouse, not

#### **Charitable Foundation**

The Foundation has a new Director of Advancement and Fundraising. **Yolanda Bronstein** has been hired on a part-time basis.

She brings over 15 years of experience in the fundraising sector with hands-on experience with a variety of fundraising methods and organizational structures and is

the common law spouse, will receive the death benefit. Divorce is the legal mechanism to determine or change a death benefit entitlement. Bill 151 will need to be re-introduced into the legislature in the 2014 fall session to make the required changes to the Pension Benefits Act. The OTPP must comply with the Pension Benefits Act (PBA); consequently amendments will be required in the future.

### **Plan Simplification Update**

A short-absence management amendment has been drafted to require members and the Ontario government to make mandatory payroll contributions for short absences that are less than five days. This will streamline administrative procedures and eliminate the buy back process for short term leaves. This amendment still needs to be approved by the Partners.

# Canadian Association of Retired Teachers (ACER/CART)

CER-CART is a non-partisan organization consisting of 13 retired teacher Associations across Canada. It represents members to the Federal government, expressing their concerns on common issues and receives requests from Associations and asks Associations to take action on common concerns. It can request, but not order, as all member Associations have autonomy.

The Annual General Meeting in June is the supreme authority. It receives resolutions from the ACER-CART Executive, its Committees, and from Associations. During the year, the Executive meets by teleconference call at least three times, as well as face-to-face twice, before and after the June AGM. ACER-CART operates on a modest budget; supported by the Canadian Teachers' Federation (CTF/CFE) with meeting rooms, secretarial and accounting help, as well as a luncheon. Johnson Inc. provides generous assistance with the AGM and updated health information.

Associations send one director and one observer to the AGM. **Norbert Boudreau** and **June Szeman** represented RTO/ERO this year.

Committees are chaired by members of the Executive:

- Communications;
- Health Services;
- Legislation;
- Nominations and Elections;
- Pensions and Retirement; and,
- Political Advocacy.

The ACER-CART website is kept current and includes newsletters, photos, updated information and links. It has also developed a Facebook with restricted access.

#### **Annual Meeting**

CTF President Diane Wallacechuk, reported on concerns with Bill C-23, the Fair Elections Act, as well as Bill 377, which targets unions and their expenditures. CTF is also unhappy with the government's muzzling of the science community, the closure of libraries, and the loss of environmental data. CTF's non partisan "Hear My Voice" initiative continues as a national advocacy movement targeting politicians, media and people of influence.

Dr. Brian Day, former President of the Canadian Medical Association and now the owner of two private health clinics, is challenging BC's ban on private health care, taking clear aim on the concept of Medicare. Doctors for Medicare Canadian and the BC Health Coalition are interveners prepared to fight this case in court USA based insurance companies are poised to jump at the opportunity to invest in private health care in Canada. The British Columbia Retired Teachers Association has donated \$5,000 to the case against private health care. ACER-CART donated \$500 and has written all Associations to consider support for the interveners.

- Encourage associations to become involved in the next Federal election as it affects seniors.
- Continue to advocate for a new Health Accord.
- Encourage associations to consider helping to fund the fight against the attack on public health care.
