

The Superannuation Committee at its meeting on September 28, 1984 supported the following motion passed by the Senate in Move

"That amendments to the Teachers' Superannuation Act (or rewriting thereof) include improvements in pension of all superannuated teachers based on the average of the best five years; such recalculation to be effective from the effective date of the Act (Amendments and the final amount to include the addition of escalation(s) to which each pensioner is entitled)."

This motion has been sent on to O.T.F.

David Fox of District 16, petitioned O.T.F. and the Legislature to include <u>all</u> retired teachers in Bill 148, the revised Superannuation Act. This motion was one of several. David's hard work has **paid** off.

A second motion from S.T.O. regarding the increase in the spousal allowance has been reworded by the Superannuation Committee as follows:

"That the Board of Governors request the Treasurer to amend the Teachers' Superannuation Act, 1983, to provide for an automatic survivors' allowance of 60% of the contributors' entitlement for all current and future survivors."

This was passed by the Board of Governors and should be included in the next biennial review of pensions.

C. <u>Goodwill Committee</u> (Ont.)

The Senate established this committee in 1977 to assist financially a very small percentage of our membership (.03 who were below poverty level). The Provincial Committee would appreciate referrals from the Districts re any member in need. Call 921-4460. 1260 Bay St., for application forms. This Provincial committee, headed by one of Toronto's own. Jim Williamson, is performing a wonderful service for our members and must be congratulated for their fine efforts.

D. Health Services Committee

You received your new, rewritten manual covering the three Services Plans in September. The contract was modified to provide more comprehensive coverage and to clarify and simplify terminology.

Potential retirees and subscribers are reminded again of the crucial 31 days time period.

As of June 30, 1984, our subscriber numbers were Hospitalization - 12,977, Extended Health Care - 12,030, and Dental - 4,855. 1983-84 produced an overall surplus of \$101.510.00 from:

A Semi-Private Hospital deficit -101,915.00 An Extended Health Care Surplus -224, 397.00 A Dental deficit -20,972,00

A deficit recovery program has been implemented Deficit as of July 1, 1983 - 48 Deficit as of July 1, 1984 23 483.230.00

Interest charges on the deficit are at 11.5%

The May 15, 1984 Senate passed a resolution to investigate the feasibility of getting outside assistance to help cover the cost of health benefits. The executive referred it to the Health Services Committee who will submit its findings as the earliest possible date.

Project Overseas Committee

Canadian Teachers' Federation is involved in recruiting teachers for overseas teaching. At the time of the November Senate meeting, four retired teachers from S.T.O. (Ont.) were serving in Gambia and two more were scheduled to go to Zimbabwe in December 1984. This makes a total of twelve of our members chosen by C.T.F. for the project. Contact S.T.O. if you are interested.

The following motion re Project Overseas was passed. "That an amount of \$5,000.00 be funded for financial aid to Third World Countries. the money to be dispersed by the Project Overseas Committee." This amount will be in addition to the \$15,000.00 already allocated.

The fourth team of volunteers includes Mr. Alex Jardine former Toronto principal.
